With regard to the last paragraph of your letter I may say that the September quarter return of the Cecilia Jeffrey Indian Residential School has not yet reached us. Today I am writing to Indian Agent Edwards requesting him to have the Principal prepare and forward this return immediately and as soon as it is received arrangements will be made to issue the cheque.

To assist you in your financing a part payment on the September quarter earnings of \$3,000.00 is being made but the full amount of earnings for that quarter cannot be paid until the return reaches us.

It would be advisable for you to communicate with Mr. Byers and point out to him the advisability of his preparing and forwarding the quarterly returns immediately following the close of each quarter.
