
With Cheque

Dear Sirs,-

With reference to your claim of \$44.57 against this Department for goods and freight in connection with work at the Cecelia Jeffrey Indian School, at Kenora, Ont., I beg to enclose herewith Department's cheque for that amount in payment of your invoice of the 15th April 1929 for \$43.23 and 25th April 1929 for \$2.34. The Department has on file your two credit notes of the 8th and 11th May for the sums of \$124.18 and .27¢ respectively. 
