

Dear Sir,-

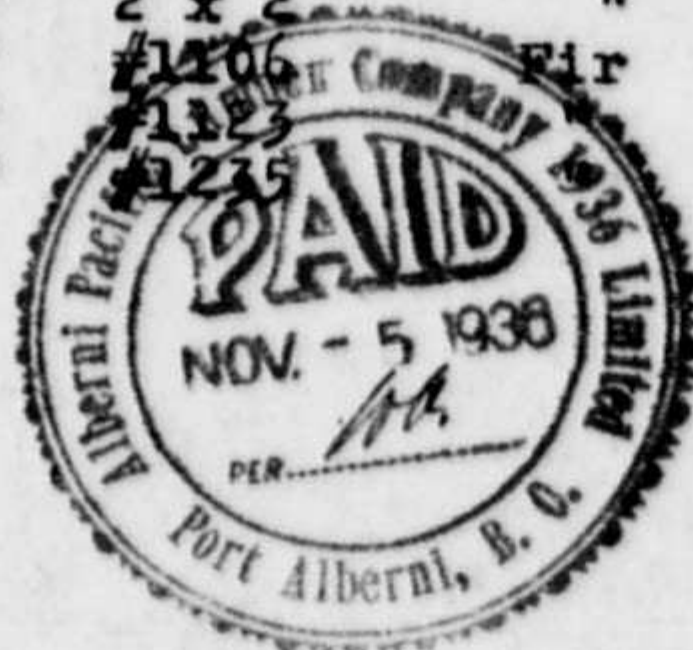

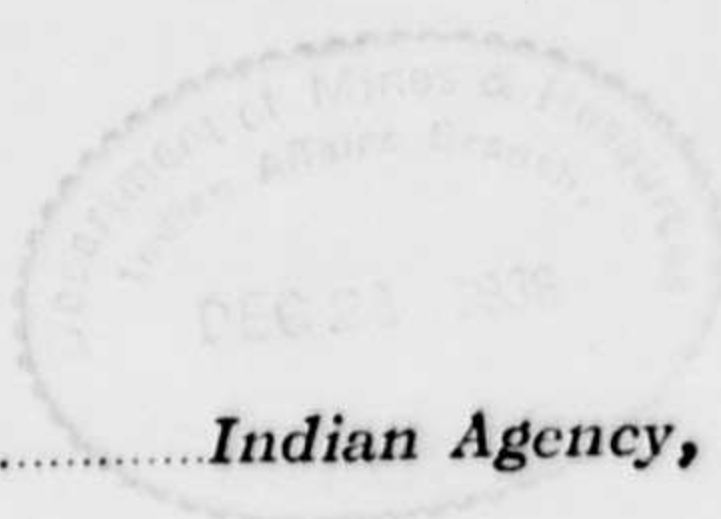

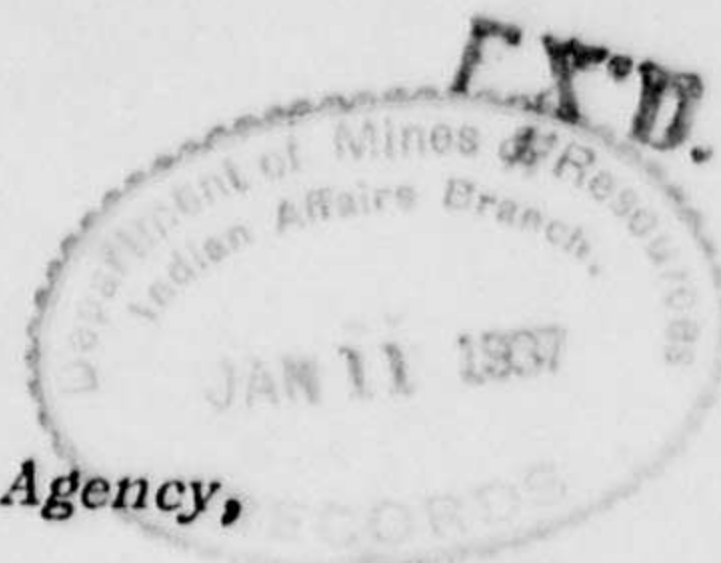
